ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be America's Pest Solutions, Inc.

ARTICLE II - TERM OF EXISTENCE

This Corporation shall exist perpetually. Commencing on the date of execution and acknowledgement of these Articles of Incorporation.

ARTICLE III - PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 1073 Narrow Gauge Court, Winter Garden, Florida 34787.

ARTICLE IV - GENERAL PURPOSE

The general purpose for which this Corporation is organized shall be to conduct and transact any and all lawful business authorized or not prohibited by Chapter 607 of the Florida Statutes, as the same may be from time to time amended. Including, but not limited to, residential and commercial pest control service and pest control retail operations.

ARTICLE V - CAPITAL STOCK

The number of shares which the corporation shall have authority to issue is One Thousand (1,000), One Dollar (\$1.00) par value per share. In the event that the stock other than common is issued or stock is transferred, compliance with Florida Statutes, Chapter 607 will be observed.

ARTICLE VI - INITIAL REGISTERED OFFICE
AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 56 Park Lake Street, Orlando Florida 32803. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this Corporation at that address is Heather L. Higbee. The Board of Directors may from time to time designate a new registered agent.
