ARTICLE ONE

The name of the corporation is Riner & Riner, Inc.  
The principle corporate address is 211 Howard Street, Auburndale, Florida 33823.

The period of its duration is perpetual.

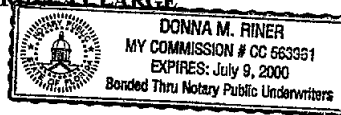
