

Articles of Incorporation

of

TalkVideo Corporation



The undersigned hereby establishes the following for the purposes of becoming a corporation under the laws of the State of Florida, by and under the provision of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

Article I

The name of this corporation shall be TalkVideo Corporation

Article II

This corporation is organized for the following purposes: To engage in the business of communications, tele-communications, consulting, sales and any other business related thereto.

Article III

The number of shares of stock that this corporation is authorized to have outstanding is initially set at 10,000,000 shares of Common Stock (10,000,000), with a par value of (.001) per share.

Article IV

Preemtive Rights

There shall be no preemtive rights.

Article V

Corporate Duration

This corporation shall have perpetual duration unless sooner dissolved by law.

Article VI

Initial Registered Office and Agent

The business and mailing address of the Corporation and street address of the initial registered office of this Corporation is 3800 Galt Ocean Dr., #712, Ft. Lauderdale,

Fl. 33308 and the name of the initial registered agent of this Corporation at that address is John R. George.

Article VII

Initial Board of Directors

This Corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the Board of Directors pursuant to the by-laws but shall never be less than one person. Article VIII

By-Laws

The power to adopt, amend, alter or repeal by-laws shall be vested in the Board of Directors and the shareholders of the company, which shall require a 2/3 vote for approval or amendment.

Article IX

Indemnification

The Corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

Article X

Special Provisions

The following special provisions shall govern this Corporation:

- A. No person shall be required to own, hold or control stock in the Corporation as a condition precedent to holding an office or directorship in this Corporation.
- B. No contract or other transaction between the Corporation and any other corporation, in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the officers or directors of the Corporation is or are interested in or is an officer or director or are officers or directors of such other corporations, and any officers, or officers and directors, individually or jointly, may be a party or parties to or may be interested in any such contract or transaction of the Corporation or in which the Corporation is interested; and no contract, act, transactions of the Corporation with any person or persons, firm, or corporation, in the absence of fraud, shall be

affected or invalidated by the fact that any officer, or officers and/or directors of the Corporation is a party or are parties to or interested in such contract, act or transaction, or in any way connect with such persons, firm or corporation, and each and every person who may become an officer or director of this Corporation is hereby relieved from any liability that might otherwise exist from thus contracting with the Corporation for the benefit of himself or any firm, association or other corporation in which he may be interested.
