

ARTICLES OF INCORPORATION OF LUNARTIC.COM, INC.

ARTICLE ONE

The name of the corporation is Lunartic.com, Inc.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.




