ARTICLES OF INCORPORATION

ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

The name of this corporation is: TAYLOR LANE, INC., with initial principal offices located at 115 1st Avenue North, Jacksonville Beach, FL 32250.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of retail sales and massage services and any other activity or business for which corporations may be incorporated under Chapter 607, Florida Statues, as it now exists or may after be amended.
