ARTICLES OF INCORPORATION
of

The undersigned person, acting as incorporator of a corporation organized under the laws Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I
CORPORATE NAME

The name of this corporation is : **IMMIGRATION SERVICES OF MIAMI, INC.**

SHARES

The total number of shares which the corporation shall have authority to issue is 1000, shares of par value with a par value of \$ 1.00 per share.

**ARTICLE VI

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.
