

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be EMBURY, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 500 Coconut Palm Road, Vero Beach, Florida 32963.

ARTICLE III - EFFECTIVE DATE

The corporate existence shall begin upon filing of these Articles.

ARTICLE IV - DURATION

The corporation shall have perpetual duration.

ARTICLE V - PURPOSE
