The name of this corporation shall be:

ARTICLE II - PRINCIPAL PLACE OF BUSINESS


**ARTICLE X - INDEMNIFICATION**

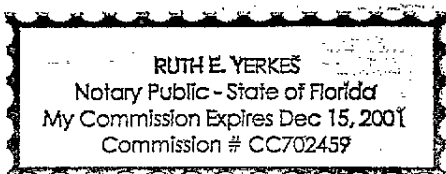
