THIRD: None of the corporation's shares have been issued and the corporation has not commenced business.

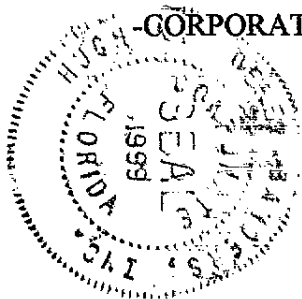
FOURTH: No debt of the corporation remains unpaid.



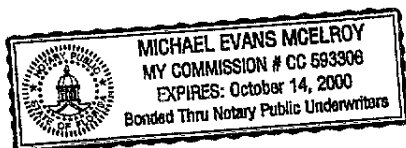


