### ARTICLES OF INCORPORATION

#### ARTICLE I

## NAME AND PRINCIPAL OFFICE

#### ARTICLE II

## DURATION OF THE CORPORATION

The existence of this corporation shall be perpetual.

#### PRE-EMPTIVE RIGHTS
