Without first obtaining the written consent of all other shareholders, no shareholder of the corporation **FILESUIT.NET CORPORATION** may sell, assign, transfer, pledge, encumber or otherwise dispose of, whether by operation of law or otherwise, any shares of the capital stock of the corporation, except as expressly permitted by and in accordance with the following provisions of this Agreement.


A shareholder may transfer all (but not part of) his shares only if no less than ninety days prior to the date of the proposed transfer such shareholder provides the other

shareholders with written notice of the proposed transfer and a copy of a bona fide offer or agreement pursuant to which such shareholder proposes to effect the transfer of his shares. Within sixty days after receipt of such notice and offer or agreement, the other shareholders shall by written notice advise the shareholder proposing the transfer whether or not they each elect to purchase, pro rata to their stock interest in the corporation, the offered shares at the same price and under the same terms and conditions set forth in the offer or agreement transmitted by the shareholder proposing the transfer. If one or more shareholders shall indicate his or their intention to purchase the shares proposed to be transferred, the accepting shareholder or shareholders shall have the right to purchase from the offering shareholder, in equal parts pro rata, the offered shares of stock at the price and upon the terms previously notified as aforesaid.

The corporation shall transfer the shares of a shareholder only in accordance with the terms of this Agreement. Any person becoming a holder of shares by means of a transfer made other than in accordance with the provisions of this Agreement shall not be entitled to vote such shares nor enjoy any of the rights or privileges of a shareholder of the corporation, nor enforce any of the provisions hereof.
