ARTICLE I NAME

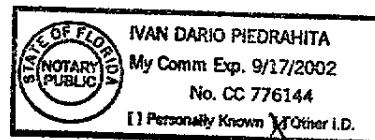


