I am the President and a shareholder of The Parrish Gardener, Inc. [Doc. No. P99000054560] which was administratively dissolved in 2013 for failure to file its Annual Report.

On July 7th of this year, I formed The Parrish Gardener LLC [Doc. No. L16000128526] (the "LLC") which was intended to be a new entity. I was the Manager and a member of the LLC.

Upon further consideration, I decided to reinstate The Parrish Gardener, Inc., and to dissolve The Parrish Gardener, LLC.
