ARTICLES OF INCORPORATION

of

The undersigned subscriber to these Articles of Incorporation, being duly licensed as a Attorney of the State of Florida, adopts these Articles of Incorporation to form a corporation under the Professional Service Corporation Act, F.S. 621, and other laws of the State of Florida

ARTICLE I - Name and Address

The Name of this corporation is JOHN A. MOFFA, P.A. (hereafter referred to as the Corporation). The Corporation's principal address is 300 Northwest 82nd Avenue, Suite #403, Plantation, FL 33324.

ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on the date these articles of incorporation are filed with the Florida Department of State.

ARTICLE III - Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Powers

This Corporation shall have all the powers conferred upon corporations organized under the laws of the Florida Statutes.

ARTICLE V - Capital Stock

This Corporation is authorized to issue 100 shares of One and no/100 Dollar (\$1.00) par value common stock.

ARTICLE VI - Pre-emptive Rights

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro-rata share at the price at which it is offered to the others.

ARTICLE VIII - Initial Board of Directors


