ARTICLES OF INCORPORATION ALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: BCK, INC., 2460 U.S. Highway 1, Mims, Florida 32754.
