ARTICLES OF INCORPORATION MIDDELTHON INVESTMENTS, INC.

TALLAHASSEE, FLORIDA

ARTICLE I. NAME AND ADDRESS

The name of the Corporation is MIDDELTHON INVESTMENTS, INC. (the "Corporation"). The principal and mailing address of the Corporation is 700 Coral Way, #9, Coral Gables, Florida 33134.

ARTICLE II. PURPOSES
