

Thank you very much for your assistance in this matter regarding Central Florida Landscape, Inc. 2002 Uniform Business Report. As I mentioned to you via telephone on January 28, 2003, I have recently received a 2003 Uniform Business Report in the mail. Upon its receipt I promptly reviewed my bank records as I recalled just having paid \$550.00 to your organization on August 27, 2002.
