Pursuant to the Florida Business Corporation Act, the undersigned incorporator of Hands On Staffing, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I  
NAME AND ADDRESS**

The name of the Corporation is Hands On Staffing, Inc. The Corporation's principal office and mailing address is 8784 Ashworth Drive, Tampa, Florida 33647.

**ARTICLE II  
BUSINESS AND ACTIVITIES**

The Corporation may, and is authorized to, engage in any activity or business now or hereafter permitted under the laws of the United States and of the State of Florida.

**ARTICLE III  
CAPITAL STOCK**

The Corporation is authorized to issue 10,000 shares of Common Stock having a par value of \$0.01 per share.

The Corporation's incorporator is Dominic Accocella, 8784 Ashworth Drive, Tampa, Florida 33647.


