# ARTICLES OF INCORPORATION OF

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be as follows:

#### DENNY'S HAIRSTYLING & DAY SPA, INC.

The principal place of business of this corporation shall be 485 - 21st Street, Vero Beach, Florida 32960, and the mailing address shall be the same.

#### ARTICLE II. NATURE OF BUSINESS

This corporation shall be formed for the specific purpose of providing hair, nail, and skin care services and massage therapy and may engage or transact in any and all lawful activities or business permitted under the laws of the United States; of the State of Florida; or of any other state, country, territory, or principality.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having One and No/100 (\$1.00) Dollar par value per share.

#### ARTICLE IV. ADDRESS
