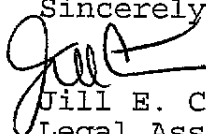

ARTICLES OF INCORPORATION

OF

JBC OF ST. AUGUSTINE BEACH CORPORATION

The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is JBC of St. Augustine Beach Corporation.

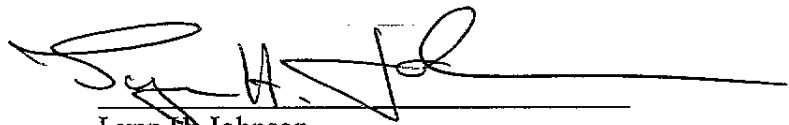

CORPORATE SHARES

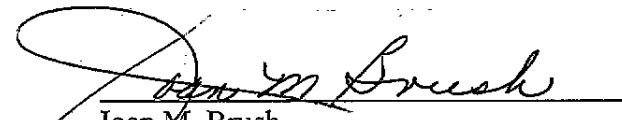
The Corporation is hereby authorized to issue 100 common shares of the Corporation at a par value of \$1.00 per share.
