## ARTICLES OF INCORPORATION OF HAVEN'S R.V., BOAT, & TACKLE CENTER, INC.

THE UNDERSIGNED, acting as sole incorporator of HAVEN'S R.V., BOAT, & TACKLE CENTER, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:
