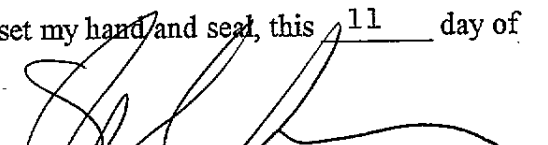
ARTICLE IX. BY LAWS

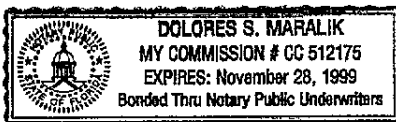

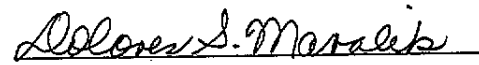

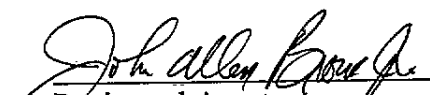
