ARTICLES OF INCORPORATION
OF
W.L. PROPERTIES, INC.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is W.L. PROPERTIES, INC., a Florida corporation.
2. **Principal Office/Mailing Address.** The principal office of the corporation is 333 Third Avenue North, St. Petersburg, Florida 33701. The mailing address of the corporation is P.O. Box 14517, St. Petersburg, Florida 33733.
3. **Existence and Duration.** This corporation shall begin existence on the date of execution and acknowledgment of these Articles of Incorporation and shall have perpetual existence.
4. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
5. **Capital Stock.** The corporation is authorized to issue 1,000 shares, all of one class, at \$1.00 par value.

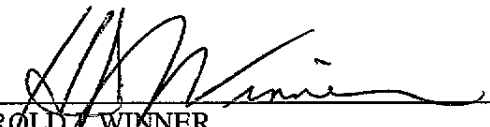

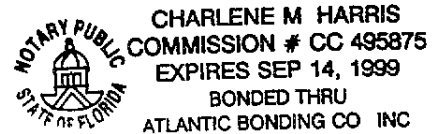
