
I talked to Robin in your department and she advised me to send an explanation and a check for \$150.

The reason for our tardiness is we either did not receive the first UBR or did not recognize it for what it was. My understanding has been that our registered agent was handling this type of matter so it may have been a case of our thinking the first UBR was a duplicate, I'm not certain at this point.

Something similar is occurring with the federal government in that we receive quarterly tax accounting forms. Our accounting is being handled by an outside service so there is no need for us to take action with these forms as the accounting firm does it.
