**ARTICLE I**  
**NAME**

The name of this Corporation is

**FIBER LINK TELECOMMUNICATIONS OF SOUTH FLORIDA, INC.**

**ARTICLE II**  
**PURPOSE**

This Corporation is organized for the following purposes:

1. To own and operate a telecommunications business.
2. To engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE III**

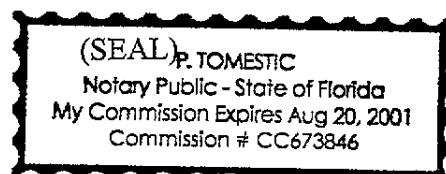
