The undersigned, acting as Incorporator of COLOR LOGIC, INC. a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the information, liabilities, rights, powers, immunities of a corporation for profit, and do hereby certify:

# ARTICLE I

The name of the Corporation shall be COLOR LOGIC, INC.

# ARTICLE II

The Corporation shall have perpetual existence.
