ARTICLES OF AMENDMENT

TO

THE ARTICLES OF INCORPORATION

OF

VISION ADVISORS INC.

Pursuant to the provisions of Section 607.1006,

Florida Statues, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:
