ARTICLES OF INCORPORATION
OF

CASTLE INVESTMENT ASSOCIATES, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

NAME AND ADDRESS

1. The name of this corporation is Castle Investment Associates, Inc., and the address of the corporation is PMB 422, 6671 W. Indiantown Road, Suite 56, Jupiter, Florida 33458.

ARTICLE II

DURATION

2. The duration of this corporation shall be perpetual.

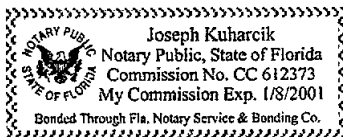
