ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
THUNDERCALL, INC.

The below-signed, constituting all of the Directors, Officers and Shareholders of the above-referenced corporation, hereby consent, authorize and adopt the following amendments to the Articles of Incorporation:

1. The name of the Corporation is Thundercall, Inc. The purpose of this Amendment is to change the name of the Corporation to Emergency Communications Network, Inc.

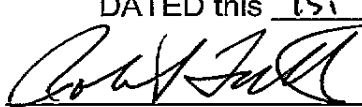
2. The following amendments to the Articles of Incorporation were adopted by the Shareholders and Directors of the Corporation on August 1st, 2001 in the manner described by the Florida General Corporation Act:
