**ARTICLE I**

**Name**

The name of the corporation is RICHARD ANDRE GOSSELIN, M.D., P.A.

**ARTICLE II**

**Duration**

The period of existence of this corporation is perpetual.

**ARTICLE III**

Initial Registered Office and Agent




