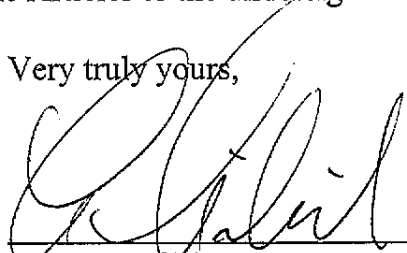

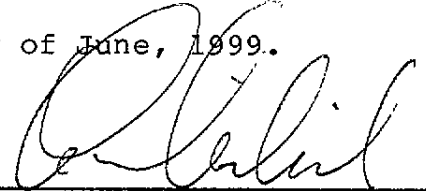

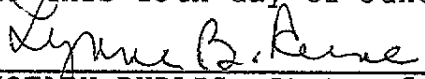
ARTICLE IX
