# ARTICLES OF INCORPORATION

## ARTICLE I

#### NAME

The name of this Corporation is BUONI MARIO, INC.



### ARTICLE II

## PRINCIPAL OFFICE

## ARTICLE III

### DIRECTOR OUORUM AND VOTING

No less than a majority of the directors shall constitute a quorum for a meeting of directors.
