#### ARTICLES OF INCORPORATION

The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a Professional Service Corporation in accordance with the laws of the State of Florida, adopts the following Articles of Incorporation:

#### **ARTICLE I. NAME**

The name of the Corporation shall be McCORMACK & ASSOCIATES, P.A.

#### ARTICLES II. REGISTERED OFFICE AND AGENT
