

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is K & P CLEANING, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Secretary of State, State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing cleaning, waxing, and maintenance services for floor covering, including new construction, and all activities normally included therewith, and such other lawful public business as may be permitted by the Statutes of the State of Florida.


ARTICLE VIII - BYLAWS

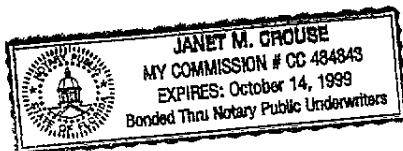

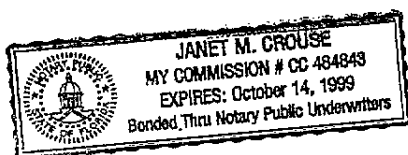
