**ARTICLES OF INCORPORATION
OF
P. S. B., INC.**

THE UNDERSIGNED, acting as sole incorporator of **P. S. B., INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be **P. S. B., INC.**

The person who is to serve as initial Director until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify are Dan Walker.

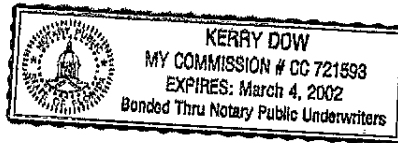
