The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

**Article I**  
**Name**

The name of the corporation is:

TIP TOP TRANSPORT, INC.

**Article II**  
**Duration**

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

**Article III**  
**Nature of Business**

This corporation is organized for the purpose of transacting any or all lawful business.

**Article IV**  
**Capital Stock**

- (a) **Authorized Capital.** The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.
- (b) **Preemptive Rights.** Shareholders shall have no preemptive rights.
- (c) **Cumulative Voting.** Cumulative voting shall not be permitted.

**Article V**  
**Initial Registered Office and Agent**

The street address of the initial registered office of this corporation is 7606 NW 88<sup>th</sup> Circle, Tamarac, Florida 33321, and the name of the initial registered agent of this corporation is Karen M. Robinson at 7606 NW 88<sup>th</sup> Circle, Tamarac, Florida 33321. The principal address as well as the mailing address are the same as the registered office address.

**Article VI**  
**Directors**

(a) **Number.** This corporation shall have 1 director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.

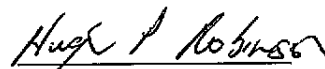

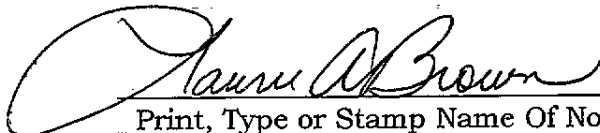

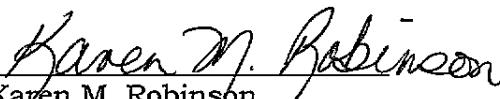
