ARTICLES OF INCORPORATION OF CYMA AUTO CENTER. INC.

The undersigned subscribers to these Articles of SSE 22 Incorporation, each a natural person competent to contract 22 Incorporation, each a natural person competent to contract 22 Incorporation associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is CYMA AUTO CENTER, INC.

ARTICLE II - NATURE OF BUSINESS
