## ARTICLES OF INCORPORATION

THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES, EACH A NATURAL PERSON COMPETENT CONTRACT, HEREBY ASSOCIATES THEMSELVES TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

### ARTICLE I

THE NAME OF THE (THIS) CORPORATION IS:

DRIFTWOOD CHRISTIAN DAYCARE & LEARNING CENTER, INC

### ARTICLE II

### ARTICLE III

THIS CORPORATION IS AUTHORIZED TO ISSUE 100 SHARES OF NO PAR VALUE COMMON STOCK WHICH SHALL BE DESIGNATED AS "COMMON SHARES."

### ARTICLE IV

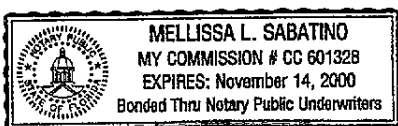
