Dear Sir or Madam:

I am writing in response to receiving the 2000 Uniform Business Report due September 13, 2000. I would like to request a waiver of the penalty due to circumstances explained below in this letter.

I started my business in July of 1999. This was a new venture for me. Most of my clients are architects. I have worked for architects for the past 17 years and have a good client base. I have never studied business management. I have a Bachelors Degree of Fine Arts in Industrial Design. I went to the Cleveland Institute of Art for five years. I am an artist /designer. I hired an accountant to do my business returns in early March of 2000. He educated me on the subject of sales tax and many other issues about running a business. I tried to understand as much as I could and took some notes, but this was all new to me and very difficult to understand. I received the 2000 Uniform Business Report due September 13, 2000 in the mail the other day. I did not understand what the form was for. The fee of \$550.00 was so high I did not know how I could pay it by the due date. I asked a friend about the form. He used to own a business and said he remembered the fee being a lot less. I called my accountant and told him about the form. He asked me if I had received any forms prior to this in the mail. I did not recall receiving any form. He told me the normal fee is \$150.00 and this form incorporated a penalty because it is normally due May 1. He suggested I write this letter to you and send \$150.00 along with it. (A check is enclosed).

I really cannot afford to pay a penalty at this time. I am having a lot of trouble collecting my fees. I am not even paying bills on time due to trouble collecting past due funds. Business is slow and income is not steady.

The reason I began my own business in the first place was because I had lost my job. I worked for my husband for the last three years in his business and he filed for bankruptcy (personal and business) in July of 1999. He had severe emotional problems and was in and out of the hospital and mental health centers. I filed for divorce in August 1999. I had been married for 19 years. He currently lives in a halfway house and is on disability and welfare. I did not file for bankruptcy and am responsible for our joint dept in excess of \$60,000 (not including house and car payments). I have a minor child that I am now raising on my own. He does not pay me child support. I work very hard to make
