ARTICLE I

NAME

The name of the Corporation is **ROYAL TRANSPORT Inc.** The principal office address and the mailing address of said Corporation is 1942 Meharry Ave. Jacksonville, Florida 32209.

ARTICLE II

DURATION

AMENDMENT


