- II. *The amendment to change its name to Lyra International Inc. was filed on January 22, 2001.*
- III. *The Corporation did not commence business under either of its names nor did it acquire any assets of any kind or incur indebtedness to any party, nor did it issue stocks, shares, or any documents, or notes, or token representing any form of gain or liability.*
- IV. *Having conducted no business transactions whatsoever, and having acquired no assets or gains whatsoever, Lyra International Inc. has no assets of any kind or profit to distribute to any party.*
