Article I - Name

The name of this corporation is: ENGLEWOOD LANDSCAPE SUPPLY,

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

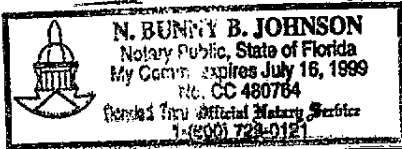
