The undersigned incorporator, Richard Houle, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is NORTHEAST CONNECTION, INC., whose corporate principal office is 97 Spring St., St. Augustine, FL 32095.

ARTICLE II NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is real estate purchase and renovation and transacting any and all other lawful business for which corporations may be incorporated under the Florida General Corporation Act.

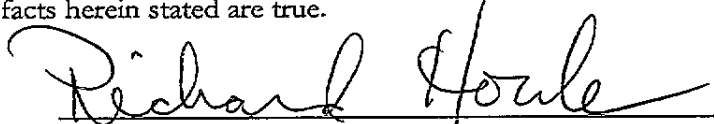
