

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors.


ARTICLE IX - INCORPORATOR

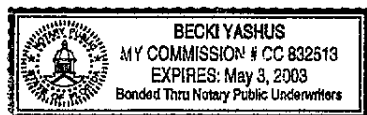
