Articles of Incorporation OF

MIGENT SERVICES, Inc.



The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I

The name of the corporation is: MIGENT SERVICES, Inc.

ARTICLE II

The duration of the corporation is perpetual and the purpose is to provide services to the public.

ARTICLE III
