The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I - Name; Principal Office**

The name of this Corporation shall be **SEVEN SPRINGS PROFESSIONAL CENTER, INC.** (the "Corporation"). The street address and the mailing address of the initial principal office of the Corporation shall be 2210 Bayou Drive, Holiday, Florida 34691, or such other place as may be designated by the Board of Directors.

**Article II - Capital Stock**

The Corporation shall have the authority to issue 10,000 shares of voting common stock, with a par value of \$1.00 per share.

**Article III - Registered Office; Registered Agent**
