ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

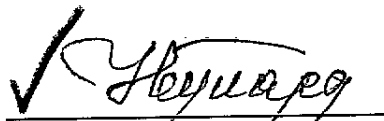
## ARTICLE VIII - INDEMNIFICATION

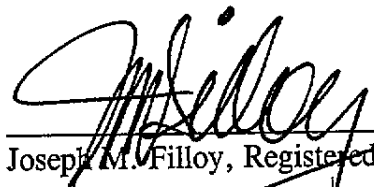
