ARTICLES OF INCORPORATION

The undersigned acting as an incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of this corporation is:

2. The period of this corporation is perpetual.

3. The purpose of this corporation is to engage in the practice of physical therapy and exercise instruction and to exercise the powers now or hereinafter granted to professional services corporations.



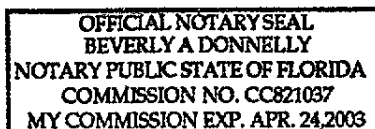
