ARTICLES OF INCORPORATION

OF

We the undersigned, for the purposes of organizing a corporation pursuant to the laws of the State of Florida do hereby adopt the following Articles of Incorporation and we do hereby agree and certify as follows:

ARTICLE I – NAME OF CORPORATION

The name of this Corporation shall be "WOOD & ASSOCIATES, ADVERTISING/MARKETING, INC."

ARTICLE II – GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation shall be:

To design, write, photograph, video, prepare, place, publish, and display in any manner, advertisements and publicity devices and innovations of all kinds for itself or for others; to print, publish, photograph, video, and distribute newspapers, books, pamphlets, magazines, periodicals, handbills, pictures, cartoons, posters, display cards; to arrange for the placing of advertisements in publications and electronics media of all kinds; to do bill posting; to manufacture, install, supply, maintain, and operate billboards, signboards, and illuminated signs; to give or arrange for the giving of demonstrations and exhibitions for advertising and marketing purposes; to supervise the preparation and production of moving picture advertisements and publicity devices; to supervise the preparation of radio, television, and Internet advertisements and publicity devices; to do a general advertising, press agency, and publicity business in all its branches; and to make all contracts and do all things proper, incidental, and conducive to the complete attainment of such purposes.

- 2.
