



ARTICLE I

NAME: The name of the corporation shall be A. R. CRAFT, P.A.

ARTICLE II

NATURE OF CORPORATE BUSINESS: This Corporation, through its officers and employees, shall be authorized to engage in every aspect of real estate functions, pursuant to Chapter 475, Florida Statutes, within the State of Florida; to engage in any activities which will facilitate and promote the practice of all functions of real estate, including but not limited to sales, rentals, management, through its officers and employees; and to invest and reinvest its funds in real estate mortgages, stocks, bonds and any other type of investments within the meaning of Section 621.08 of the Professional Service Corporation Act; and to purchase and own real and personal property; to engage in all acts necessary for the rendering of professional services within the practice of all functions of real estate, including but not limited to sales, rentals, management. This Corporation shall not be authorized to engage in any business other than the practice of all real estate functions pursuant to Chapter 475, Florida Statutes, and as may be amended from time to time, and any and all chapters of Florida Administrative Code related thereto.



ARTICLE III

CAPITAL STOCK: This Corporation is authorized to issue a maximum of One Hundred (100) shares of stock. The shares of stock authorized shall be common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

ARTICLE IV

INITIAL REGISTERED AGENT AND INITIAL REGISTERED OFFICE:

The Corporation's initial Registered Agent and Registered office in the State of Florida shall be: Ana R. Craft located at 8701 S.W. 137 Avenue, #103-104, Miami, Florida



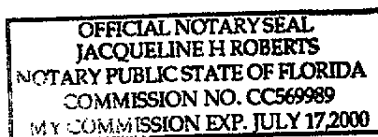
